From footsteps and pathways for the lifelong learner - Final results of the EQF-Pro Project

Two years ago, the European Qualification Framework (EQF) was adopted and **EQF Pro**, led by EUCEN in partnership with a consortium of ten partner Universities across Europe was among the first projects supported by the European Commission to test and develop the EQF.

Key objective of the EQF Pro project was to identify barriers and door openers for progression and mobility par-

ticularly at the transition point between the levels 5 and 6 of the EQF which addresses qualifications suitable for Higher Education as well as for Vocational Education.

Through an in-depth analysis of selected Banking and IT qualifications and an intense discussion and collaboration process with all partners, external stakeholders and experts, the project has developed recommendations

which aim to improve the articulation between these levels and thus contribute to the further development of the EQF.

These recommendations are available now in the Executive Summary and the final report of the project and can be found together with all other produced materials, via the project's website.

On 28 May 2010, the European Commission is organising the conference "**Financial Literacy: Dolceta**" in Brussels.

The European Commission project DOLCETA, managed by EUCEN, especially its new section on "Financial Literacy for teachers", will be presented and financial literacy will be discussed in the context of the financial crisis. The conference will bring together about 200


participants representing consumer and teachers associations, the banking industry as well as national government officials and journalists.

Participants will have the chance to familiarise with the new DOLCETA section and listen to various speakers' views on the issue of financial literacy.

Following the section on "Financial Services" in

general, "Financial Literacy" was launched in April 2010. Targeted at primary and secondary school teachers it provides free downloadable information, as well as new teaching and learning resources regarding Financial Education.

The conference will be web streamed.

Stakeholders from across Europe will meet and draw on experiences gained under the current programme phase (2007-13) in order to explore possible avenues for the future of the programme under the EU's next budgetary period through the four parallel sessions: (1) *Cross border*

exchanges of learners and teachers, (2) Transnational partnerships between education and training institutions, and in particular with employers and regions (3) Simplification of the programme and the way it is managed, and (4) Social inclusion.

EUCEN has been invited to participate and will report on the discussions after the meeting. Look out for our next issue!
