## DIALOGUE - Bridges between research and practice in ULLL

The kick off meeting of DIALOGUE was held in Barcelona, 25-26 January 2011. The main aim of this multilateral Grundtvig network will be focused on the creation of a European Space for Dialogue between academic research, professional practice in ULLL and European policy makers. In a mutual learning setup, the transfer of research into the field of professional practice in ULLL and the systematic involvement of practitioners in research will be at the heart of the network.

The exchange of key information, best practices and innovative models will be the guiding principle for the upcoming three years and the work

will be structured around four thematic groups: Access and Progression, Learning and Guidance, New Media and Quality.

**DIALOGUE will create an European Space between academic research, professional practice in ULLL & the European policy area**

Around these themes the partners will compare and analyse case studies, produce national reports and identify key-drivers as well as barriers and constraints to reinforce a real DIALOGUE.

The networking dimension will play an essential role in the internal communication as well as in the outreach to other EUCEN members and the wider expert community in ULLL and Adult Education in Europe.

How can the European policy debate and the DIALOGUE between all stakeholders involved in research and professional practice in ULLL be stimulated and sustained? All partners involved are keen on starting to tackle these key questions and the network will continue the DIALOGUE with all EUCEN members keeping you informed about its progress and findings.

EUCIS-LLL has organised the *First Lifelong Learning Week* that will be held at the European Parliament in Brussels (BE). The Fair and meetings will take place between 14-17 March 2011.

Amongst the meetings, events and activities that have been scheduled, we want to highlight a Round Table with deputies on the social dimension of education and

training and a Public Hearing on mobility at the European Economic and Social Committee. EUCEN will be present in the Fair and related events.

The **C**ollaboration **O**n **M**odernizing **P**olicies **A**nd **S**ystematic **S**trategies on LLL was the main focus for the COMPASS consortium with its last project meeting being held in Barcelona from the 27-28 of January. The short term project, financed under the transversal programme (KA1) of last year's ECET call was set to receive valuable information during one year on the implementation of LLL strategies on institutional, regional and national level in Europe. Taking reference on the European Universities Charter, two surveys have been prepared, and carried out asking both Higher Education Institutions as well as governmental bodies (Ministries, etc.) about their engagement towards the 10 commitments on LLL.

Thanks to the great commitment of the EUCEN members, the complex online-questionnaire received more than 100 responses from HEI throughout Europe in a short period

of time over summer 2010. In parallel, interviews with key-policy makers were undertaken in those countries represented in the COMPASS consortium.

The project meetings realised in Porto (February 2010) and Barcelona (September 2010) provided the basis for their main dissemination event organised during EUCEN's last conference in Lille (November 2010), where key results were shared and discussed with a broad audience of EUCEN members, EC-representatives and other key-policy makers and experts in Europe.

During the last project meeting in Barcelona in the end of January 2011, the partners reviewed all results and prepared the final dissemination products.

The main aim of these materials is to give a general overview of the different national policies and challenges in order to feed the

European reflection. The analysis was based on the discussion of the three main policy papers: the EU 2020 strategy, the ET 2020 and the Leuven Communiqué. The final result is oriented to bridge the gap between the policy making process of LLL at EU level with statements of various stakeholders and the situation of Universities in their respective contexts

LLL and in particular widening access in HE must become part of our education system to face the demographic change and the regular need to update and develop skills in line with changing economic and social circumstances. Based on the COMPASS findings the key question of the European policy community: "How to make LLL a reality" seems to remain both vision for the future and permanent endeavour in the present for all stakeholders involved.



## IMPLEMENT meets in Barcelona

The partners of IMPLEMENT - *Implementing ULLL through training and development* - met in Barcelona 12-13 January 2011. During this first meeting the consortium had the opportunity to work with the training materials produced by the BeFlex Plus project, which IMPLEMENT will actively exploit during the two years of life of this project.

The consortium, composed by 12 partners (including EUCEN as contractor) will adapt the training materials to the reality of 6 different countries and use them in a local/regional/national context.

**IMPLEMENT will develop on-line training materials for ULLL professionals**



In addition, the training materials will be made accessible through an interactive on-line platform for ULLL professionals to update their skills and knowledge. The first online tests will be carried out during EUCEN's conference in Genoa (16-18 November 2011). The full test will take place in EUCEN's autumn conference in Malta in November 2012.
